- " Won't give specific tag numbers
- Chance to ask questions
- Take notes



How an Inspector Works Through the Survey Process

Activity Bathing Complaint



Plan of Correction (PoC)

- Address all required elements
- Be sure to think systematically, and consider why the deficiency happened
- " Thoroughly read entire report



Plan of Correction (PoC)

- " Choose viable and appropriate completion date
- " Implement and document everything you do
- " Plan of correction is a public document



Revisit

- " Desk revisit vs. Onsite revisit
- " Only review from completion date forward
- Focus is on effectiveness of PoC
- " Agency can be re-cited if deficient practice still present
- " New deficiencies can also be cited



- " Currently 716 licensed Home Care Agencies
- " Approximately 10 new licenses issued per month on average
- " Every county in Colorado is being served

Types of agencies:

- . 16% Class B only
- . 37% Class A or B and State Medicaid certified
- . 13% Class A only
- . 29% Class A and Medicare/Medicaid certified (medical)
- . 5% HCA, IDD

- [™] Between 5/1/17 4/30/18, there were 80 Class A relicensure surveys
 - . 51 agencies QMP effective, no deficiencies cited
 - 21 agencies had an expanded survey because the QMP was ineffective or not operational

 - . 97 agencies QMP effective, no deficiencies cited
 - 18 agencies had an expanded survey because the QMP was ineffective or not operational
